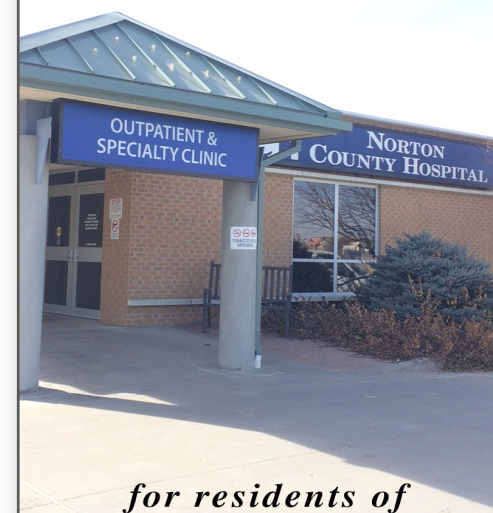

## About Norton County Hospital & Norton Medical Clinic

Our hospital is a 25-bed critical access hospital and Level IV trauma center, and along with Norton Medical Clinic, provides medical services for residents in Norton County and surrounding northwest Kansas and southwest Nebraska communities. We have 130 skilled employees to assist our medical providers in all levels of inpatient care, a full range of outpatient ancillary services and several visiting physician specialty clinics.

Because of the many services the hospital and clinic continue to provide as they evolve to meet more demands for health care, patients have the convenience of staying close to home to receive the care they need, which also positively benefits the local economy. The hospital's roots trace back to the early 1900s, but it has been named Norton County Hospital since 1945.

Five-year averages show Norton County Hospital will annually:

- Deliver 60 babies
- See 18,700 patients for outpatient services
- See 1,800 patients in specialty clinics
- Attend to 21,400 patient visits at Norton Medical Clinic
- Witness 3,250 days of patient hospital stays
- Provide care for 2,200 emergency visits

## About the Norton Regional Health Foundation

The Norton Regional Health Foundation, started in 2016, is a 501(c)(3) nonprofit organization that focuses on rural health and health care.
